

#### 2022 MemoryCare Director's Perspective

In my role as MemoryCare's executive director, I am continually inspired by families we serve and by my colleagues. However you look at it, dementia is a challenging disease. Every family, every person is different and while researchers search for ways to prevent dementia, treat it, manage it, learn more about it, our teams are laser-focused on providing expert, evidence-based care that makes a difference in lives <u>now</u>. *This is our passion*. For all of us at MemoryCare, it is a privilege to be here and provide the best possible care.

In 2022, we served 1,137 people with dementia and 3,479 of their family caregivers through our clinical care management program and 2,157 in our educational programs. Our Founder/Medical Director, Margaret Noel, MD, established MemoryCare after practicing as a general geriatrician in the community for over 10 years during which she saw the fundamental importance of family caregiver involvement in the care of a person living with dementia. She also saw the limitation of insurance reimbursement to cover the cost of such care making it a challenging to offer in a sustainable way. Alongside our unique *clinical* model, she wisely developed a charitable "business" model as well and, with community support, our work has been possible these past 22 years. MemoryCare teams have served thousands of families and *provided over \$13,000,000 in charitable service*. We are now an internationally-recognized, award-winning dementia care program. In 2022, the *Journal of Alzheimer's Disease* published an article demonstrating the tangible benefits of our virtual education program for caregivers as they navigate their journey with dementia.

Every year we ask families for input about how our work affects their lives and how we might improve our program to meet needs. Intuitively we know our program makes a difference and, through a more formal process of evaluation, you can see in this graph what families have said over the past 5 years. 99-100% report being satisfied with our program and 99-100% say they would recommend MemoryCare to other families for whom dementia is an issue. The results are humbling and their consistency underscores the most common phrase I see in comments that **MemoryCare is, "A lifeline"** for many families through their journey with dementia.



In 2022, Elizabeth Stavish, MBA, LNHA joined our staff as Associate Director and alongside her business and leadership skills brought warmth and compassion to our organization. We welcomed care managers, Rebecca Carter, PTA and Kali Fleagle, BSW, development and technical assistant, Kylie Robinson, and scheduler, Hanna Ledford who have been wonderful new team members as well. We partnered with the Asheville Buncombe Institute for Parity Achievement and the Shiloh Community Association in development of our Foot Clinic and Health Education program with support from the WNC Bridge Foundation and will continue the program through a Human Services grant from the Community Foundation of WNC. The MemoryCaregiver's Network continued its peer support groups virtually and our electronic newsletter was sent to over 4,200 caregivers. We will miss Pat Hilgendorf who retired from her role as co-facilitator with Network support groups after 10 years with MemoryCare in that role. Thank you, Pat!

We are grateful for operational support received this year from Buncombe County, Pisgah Health Foundation, the WNC Bridge Foundation, and the United Way of Asheville Buncombe County for service to low-income families and to the Dogwood Health Trust for support of our virtual education program. Forty-two percent of those served in 2022 were low-income by Federal Poverty Standards and in need of care. This year, 100% of our staff and board of directors gave in support of our operations. We have an incredibly dedicated team at every level for which I am deeply grateful. I am pleased to share this report of our 2022 activities and appreciate your interest in our work.

#### **MEMORYCARE 2022 PROGRAM SUMMARY**

#### Who Are We?

- ❖ MemoryCare is an independent, community-based, charitable organization established in June of 2000 in Western North Carolina. We serve adults with cognitive impairment and their families with a model that *integrates* education and support of caregivers with medical care of those with dementia. Our services include:
  - Accurate diagnosis (through cognitive testing and focused physical examination)
  - Caregiver training, counseling, and support
  - Disease planning (respite and in-home care options, long-term care planning, prompting to address necessary financial/legal issues and safety issues unique to the disease)
  - Behavioral management
  - Coordination of services provided by other agencies
  - Prescriptions for dementia-related medications
  - Help filing for assistance for low-income families
  - Assistance with end of life decision making/advance directives
  - Provision of written care plan to families in coordination with primary care physicians
  - Guided introduction to our lending library of caregiver resource materials
  - Education on aging issues to the community and dementia-specific training for health care professionals
  - Home visitation program in Buncombe County for clinical assessment when needed
- Our clinical, care management and educational services are provided by a team of six physicians, one nurse practitioner, four social workers, one registered nurse, and one physical therapy assistant.
- ❖ In 2022, we had eighteen full-time and five part-time staff members.
- ❖ A dedicated Board of Directors comprised of community volunteers governs MemoryCare.
- ❖ To reach more rural areas, MemoryCare has a satellite in Waynesville serving Haywood & counties farther west.
- ❖ To address our waiting list for enrollment, MemoryCare expanded services in 2002, 2006, 2008, 2012, 2015, 2018, and 2020 and established a home visit program in Buncombe County. We hope to add a new care team in 2023 to address the ongoing need for best practice dementia care in our WNC community.
- ❖ In 2022, with support from The Dogwood Health Trust, we began a 3-year project to extend our virtual education program for low income families.
- We offer a Caregiver Consultation for caregivers who need resources prior to (or instead of) enrollment.
- ❖ MemoryCare's model of care incorporates best practice guidelines outlined by The Alzheimer's Study Group, National Alzheimer's Plan, and a DHHS review of dementia programs and Medicare's Dementia Quality Measures.
- We are a non-profit, charitable organization because of the limited reimbursement available for comprehensive dementia care *and* to ensure that all with need have access to our program.
  - It costs on average \$1,936 per family per year for the comprehensive care MemoryCare provides.
  - Per independent audit (2021), 89 cents of every dollar raised goes directly to services. On average, half of MemoryCare's annual income is from charitable funds through grants, donations, and investment income.
  - In addition to charitable funds, our program has income from patient insurance reimbursement and a cost-sharing caregiver fee from enrolled families *that is waived for those unable to afford it.*
  - In 2022, twenty one percent of caregiver fees were waived due to an inability to pay the cost.
- ❖ MemoryCare would not exist without the generous support of individuals, foundations, and community agencies who have supported our program over the years.

#### Who Do We Serve?

- ❖ In 2022, we served 1,137 people living with dementia and 3,479 of their caregivers through our clinical program.
- ❖ Individuals with dementia seen in our clinical program ranged from 52 to 99 years of age with average age of 80.
- ❖ 55% of enrolled families came from Buncombe County with the remainder from 17 counties in WNC (42%), 2 counties in other parts of NC (1%), and from out of state (2%).
- ❖ 52% of MemoryCare's primary caregivers have a spousal relationship, 40% are children of the person living with dementia, 6% are other family, 1% have a non-familial relationship, and 1% are paid caregivers.
- 90% of the people with dementia seen by MemoryCare teams are living in their homes, 7% in assisted living facilities and 3% in skilled nursing facilities.
- ❖ 42% of our patients are considered low income by HHS Poverty Guidelines.
- ❖ 6.5% of MemoryCare clients are from the Givens Communities.
- Professional education is provided to medical students, physicians in training, geriatric and hospice fellows, nursing, social work, dental and other students. We also provide training for dementia care specialists.
- ❖ MemoryCare facilitated 165 presentations, one virtual caregiver education conference, and reached 2,157 individuals (plus radio and television audiences) with dementia-related education.

#### Why Are We Needed?

- ❖ *Dementia is common*: 1 in 9 people 65 and older in the USA has Alzheimer's or other type of dementia, and 1 in 3 seniors dies with Alzheimer's or another dementia (Alzheimer's Association, 2022 Facts and Figures).
- \* There is no cure for the disease: Intensive research continues but until there is a cure, families need expert guidance and support such as MemoryCare offers to manage the disease as well as possible.
- ❖ Age is the number one risk factor for dementia: Our WNC community is older than the rest of the state and country. Of the 18 counties in WNC served by MemoryCare in 2022, on average 25.2% of the population is age 65 and older compared to 16.8% in the rest of the state (U.S. Census Bureau, V2022).
- ❖ The prevalence of dementia is growing: North Carolina is expected to see a 16.7% increase in in the number of people with Alzheimer's dementia between 2020 and 2025 (Alzheimer's Association, 2022 Facts and Figures).
- \* MemoryCare is a model program for dementia care: Our work is a testament to the possibility of including family and providing best practice care for those with dementia in spite of limited insurance reimbursement.
- ❖ Dementia is a chronic, progressive illness that can take years to progress: Studies consistently show that active management of the disease with routine engagement of caregivers such as MemoryCare provides can improve quality of life through all stages of the disease both for the person living with dementia and their caregivers.
- ❖ Dementia is the costliest of diseases of aging: In 2022, Alzheimer's and other dementias will cost the nation \$321 billion (Alzheimer's Association, 2022 Facts and Figures).
- MemoryCare helps save healthcare costs: MemoryCare offers an affordable alternative for the medical care of those living with dementia that saves healthcare dollars by facilitating accurate diagnosis and by educating families about potential safety risks and appropriate utilization of the acute care system.

#### Who Are Our Supporters?

- ❖ 100% of MemoryCare's staff and Board of Directors give in support of our program.
- ❖ The majority of donors have been touched by MemoryCare services.
- ❖ Givens Estates showed visionary leadership in 2000 in giving us a home to launch MemoryCare and for being a steadfast partner throughout the years. They generously provide an in-kind land lease for *The SECU Center for MemoryCare* and assistance with the cost of building maintenance.
- ❖ MemoryCare received significant grant assistance from the following foundations in the past three years: Members of the SECU Foundation, The Duke Endowment, The Dogwood Health Trust, WNC Bridge Foundation, Pisgah Health Foundation, People in Need grant from the Community Foundation of WNC, The Cannon Foundation, Deerfield Episcopal Retirement Community, the Buncombe County Aging Coordinating Consortium (BASA), and the United Way of Asheville and Buncombe County, alongside support from other smaller foundations, charitable trusts, corporations, and churches.
- ❖ In 2022, Advent Health provided generous sponsorship for Caregiver College.
- Space for our Haywood County Satellite Clinic is provided by the Haywood County Senior Resource Center.
- ❖ In 2022, MemoryCare received charitable donations from 850 individuals, 8 foundations, and 36 community partners/sponsorships allowing *MemoryCare to provide* \$1,095,231 in charitable services that help ensure our program is accessible to all with need and that fees remain affordable.
- MemoryCare appreciates the dedicated volunteers who commit their time in support of our program.

#### Who Are Our Collaborators?

- MemoryCare enjoys collaborative partnerships with the Givens Communities and the Senior Resource Center of Haywood County.
- ❖ We provide education to healthcare professionals from a variety of disciplines and have collaborative agreements with Mountain Area Health Education Center and Western Carolina University.
- ❖ MemoryCare has strong working relationships with numerous other organizations serving the geriatric population in WNC including Asheville Buncombe Institute for Parity Achievement, Buncombe and Henderson County Councils on Aging, Land of Sky Regional Council, Black Mountain Neuro-Medical Treatment Center, adult day programs, local retirement communities, and the Alzheimer's Association.

We cannot over-emphasize how helpful and meaningful MemoryCare has been throughout our experience. We have recommended these services to several families, and endorse MemoryCare fully.



# MemoryCare 2022 Operating Income


Total Operating Income: \$2,204,128\*

- MemoryCare is a 501(C)(3) non-profit, charitable corporation (Federal Tax ID: 56-2178294) governed by a board of directors who are members of our community.
- We are licensed by the state of North Carolina to do charitable solicitation.
- Since inception, the program has received significant grant support from The Duke Endowment, The Fullerton Foundation, The Community Foundation of Western North Carolina, The Janirve Foundation, The Kate B.
